





# **Section 1: Specifications**

# 1.0 General Background

The Funds and Programmes Division (FPD) within the Parliamentary Secretariat for the EU Presidency 2017 and EU Funds, Ministry for European Affairs and Implementation of the Electoral Manifesto (MEAIM), as the National Focal Point/Programme Operator for the EEA and Norwegian Financial Mechanisms 2009-14, is requesting a quotation for the provision of editing services in relation to a promotional video in connection with EEA and Norway Grants 2009-2014

The expenditure will be co-financed from the Technical Assistance and Programme Operator Budget of the EEA and Norwegian Financial Mechanisms 2009-14.

The selection of the successful bidder will be decided on the overall price and will take place in line with the Public Procurement Regulations (LN352/2016) and the cheapest technically compliant will be awarded the bid.

# 2.0 Specifications

FPD requires the provision of editing services in relation to a promotional video in connection with EEA and Norway Grants 2009-2014. The length is to be of around 5 minutes and it should also include captions and background music. The videos and images will be provided by the contracting authority. The co-financing banner, including text, Maltese Flag and programmes' logos, will also be provided by the contracting authority and will have to be included in the final version of the video.

The contract will be awarded to the bid providing the total lowest overall cost to the client, which is also fully compliant with the specifications and requirements above.

Final Payment (100%) will be executed after delivery and based on the Invoice issued by the winning bidder. A **fiscal receipt** covering total payment must be issued thereafter.
