Where are we now?

- First call: approved by the Monitoring Committee on 9th February 2016
- Second call: approved by the Monitoring Committee on 5th October 2016
- Third call: approved by the Monitoring Committee on 13th March 2018



€244.5 Million ERDF already committed!

- Fourth call: closed on the 22nd June, and the official eligibility report will be issued in the coming weeks.

- 1st June 2018 – 30th November 2018 : Progress Report Submitted **1st March 2019**
- 1st December 2018 – 31st May 2019: Progress Report Submitted **1st September 2019**

- Phase 1 (30 or 36 months): 1 report every 6 months
- Phase 2 (24 months): 1 report every 12 months
